
General Conditions: -

- 1. The initial term of appointment by Deputation (including short term contract) will be **one (01) year** from the date of assumption of charge of the post, which may be extended, if needed.
- 2. Terms & Conditions for deputation will be as provided in DoPT O.M. No. 6/8/2009-Estt. (Pay II) dated 17/06/2010, as amended from time to time.
- 3. Shown above are the total number of available positions (likely to vary at the time of selection). The number of positions filled shall be based on the availability of suitable candidates, and the requirement and ability of the Centre to support their laboratory set up.
- 4. All educational, professional and technical qualifications should be from a recognized Board / University.
- 5. The experience requirement specified for the said post should be the experience acquired after obtaining the minimum educational qualifications required for the post.
- 6. The initial appointment by Direct recruitment/ contract including short term (>2 years) shall be on probation for a period of 2 years from the date which he/she assumes charge of the post.
